

## Markets

Oil continues to gain on meal. Soybean oil futures are at the highest level since late last fall. Market chatter about potentially lower Canadian canola supplies and higher demand for palm oil is helping sovoil values on the CBoT. The new proposed US mandate for biofuel is also supportive to oil values. Meal prices have fallen on talk of lower Chinese domestic soymeal prices and increased South American soybean supplies. The world oilseed market is expected to be more oil driven in 2015 rather than meal. Oil stocks are tighter than a year ago. This is all positive news for sunflower prices. Most market analysts feel US soybean prices should trend lower unless the US 2015 summer weather causes production issues. There is still time to plant sunflower to utilize the excess moisture in the soil. Sunflower may be planted until late June and hybrid seed is still available. Crushers are offering new crop contracts that have cash and or Act of God (AOG) production clauses. Weather and planting progress reports will continue to be the main market drivers in the near

## **CROP PROGRESS**

Planting is way ahead of schedule in North Dakota, where 76 percent of the sunflower crop is reported planted. That compares to 55 percent last year and 56 percent on average. 33 percent of the sunflower planted in North Dakota is already emerged as well. Minnesota is also ahead of average, with 90 percent of the sunflower acres planted.
